**W.P.(C) 7927/2012** and

**W.P.(C) 3686/2013 & CM 16194/2014(for laying down directives for prevention of sexual abuse of the School Going Children)**

1. Pursuant to the previous order dated 11.12.2017, counsel for the Delhi Police, on instructions, submits that 10 CCTV Cameras would be installed in each of the 192 Police Stations and the additional 42 Police Chowkis.

2. The Court had required the Authorities to ensure that footage is made available and stored for at least a month and – may be upto three months – depending upon the technical feasibility of handling data.

3. Having regard to the submissions made, 10 CCTV Cameras to be installed in Police Stations and Police Chowkis. The CCTV Cameras shall be installed at the following locations:-

- (i) *Duty Officer Room*
- (ii) *Lock Up*
- (iii) *SHO*
- (iv) *Malkhana & Kot (where ammunition is kept)*
- (v) *Sankarman Kaksh/Visitor Room*
- (vi) *Women Help Desk*
- (vii) *Front/Side at the perimeter of Police Station Building*

*(viii) Corridor at ground and first floor of the Police Station Building.*

4. This order shall be read as a part of the order dated 11.12.2017.
5. The case is now listed on 31<sup>st</sup> January, 2018 for the respondents to file their Action Taken Report.
